CLIENT PROBLEM ?

The client had an existing HSE management system in place from a previous engagement with another consultancy who had developed a system, then audited their own system and got this accredited to an international standard. This system would not stand up to external scrutiny from client audits.

Our Solution

A health and safety legal risk register was developed which identified all client activities as well as relevant best practice and international standards relating to the industry.

Summary of Outputs

- Creation of specific activity risk assessments

- Creation of induction, orientation and training material relating to the HSE Management system
- Ensured compliance with UAE HSE requirements and was structured to incorporate this into the clients day to day operations and activities
- Ensured that hazard identification and assessment had been adequately covered
- Worked with the clients top management to ensure that the legal requirements for health and safety were correctly discharged within organisational roles and responsibilities
- Ensured that emergency preparedness and response were planned for
